- If a child's name is mentioned elsewhere (for example, because of some work that is displayed on the site) only the first name will be used, and it will not be linked to any photograph of the child or any other personal details.

Occasionally, the newspaper or other media sources may require a class or individual children picture for specific achievements within school, where the name also may be requested.

I hope any concerns you may have are met by the above points. If you have any queries please do not hesitate to contact school.
